During the public comment periods for those TR3s that use a public comment process, and for an indeterminate time thereafter, copies of draft TR3s are available for free download from designated sites. Prior to public comment period closure, comments on draft TR3’s may be made by any organization or individual – X12 member or not; but only via the online conferences at designated locations. Download and comment designated sites and locations are individually listed in the Public Review Announcement for each TR3.
